### Food Chain Declaration

## NOTES:

1. All vendors, purchasers and visitors to the York Auction Centre are bound by Conditions of Sale of the Livestock Auctioneers Association 1998, the York Auction Centre Terms of Business, the York Auction Centre Animal Welfare Policy and the Animal Gathering (Interim Measures) Order 2002.
2. Official Ear Tag: This must be the complete number i.e., both sides of old tags, or full details of new tags. Animals born on or after 1<sup>st</sup> January 1998 must have 2 Ear Tags: a primary and secondary tag in each ear. All cattle offered for sale MUST have 2 tags on arrival at the market.
3. Sex: Initials will do (Str – Steer, Hfr – Heifer, YB – Young Bull or Cow)
4. Please tick if individual animals meet Farm Assurance residency requirements
5. Vendors must provide their Farm Assurance number prior to sale for their stock to be sold as FARM ASSURED. The market will store this number together with its expiry date on their database. Animals MUST have been on a FARM ASSURED holding for the previous 90 days to qualify as FARM ASSURED
6. IT IS THE VENDOR'S LEGAL RESPONSIBILITY TO ENSURE THAT ALL INFORMATION ON THIS FORM IS CORRECT AND THAT EACH ANIMALS EAR NUMBERS ARE RECORDED CORRECTLY. THE AUCTIONEERS HAVE NO LEGAL RESPONSIBILITY FOR THE CORRECTNESS OF THE INFORMATION SUPPLIED.
7. Copies of the Livestock Auctioneers Association Conditions of Sale are displayed in the market. Copies are also available for inspection at the accounts office along with the York Livestock Centre Terms of Business and the York Auction Centre Welfare Policy.
8. Cleaning and Disinfection of vehicles must be completed as soon as reasonably practicable after unloading and in any case within 24 hours or before the vehicle is next used for carrying livestock whichever is the soonest.
9. The new EHC regulations requires the veterinarian in an exporting abattoir to sign off all consignment stating that the animals have originated from establishments that have received regular animal health visits from a veterinarian for the purpose of the detection and signs of disease.
10. PLEASE NOTE: that the farm of origin's official veterinarian could be private vet, an APHA vet (for example TB testing, scrapie surveillance), or a vet visit as part of an assurance scheme.
